**ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS AND RELEASE
OF LIABILITY INHERENT IN EQUINE ACTIVITIES**

I understand that there are risks inherent in activities involving horses during the Neal Hermanson Memorial Ranch Rodeo and Ranch Horse Competition. I recognize that these risks include, but are not limited to, the following:

- A horse may react unpredictably for many reasons including behavior of people as well as of other horses, medication, and distractions such as sounds, sudden movements, unfamiliar objects, and other animals.
- Other riders or participants in horse-related activities may lose control over their horses or not act within their abilities to control horses.
- Physical hazards such as posts, poles, fences, weather and ground conditions (both surface and sub-surface) can cause or increase danger and injury to horses and people engaged in horse-related activities.
- The reactions and behavior of a horse to incidents, hazards and conditions could result in harm and serious injury to a rider, to by-standers, as well as to other animals and their riders.
- Horses and horse-related activities include, but are not limited to riding, grooming, feeding, boarding, trailering, loading, stalling, training and attendance or participation in shows, rodeos and events.

I understand the inherent risks, dangers, and rigors involved in horse-related activities. I am fully capable of participating in these horse-related activities, and do so at my own, sole risk.

ASSUMPTION OF RISK

I assume full responsibility for any and all risks of bodily injury, death, and loss of or injury to personal property that may arise from or be caused by risks inherent in equine and cattle activities, as well as any and all expenses associated therewith, both for myself and for my horse(s).

RELEASE OF LIABILITY

I hereby expressly waive and release any and all rights and claims for injury or damages which I may have, or which may hereafter accrue to me against the Neal Hermanson Memorial Ranch Rodeo and Ranch Horse Competition, their heirs, agents, representatives, volunteers and/or sponsors, arising from or caused by any risks inherent in equine and cattle activities on property and/or the grounds or arenas owned or leased by the Neal Hermanson Memorial Ranch Rodeo Competition or at any activity, sponsored or associated with them shall occur.
